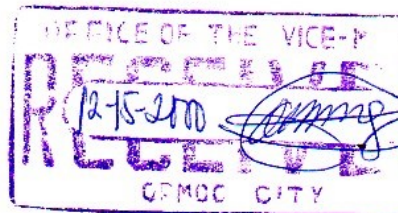


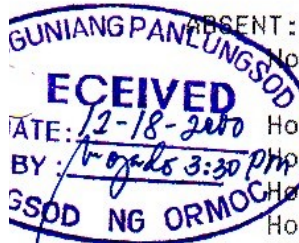

WHEREAS, this Sanggunian is in receipt of a letter dated 5 December 2000 from the Honorable City Mayor Eufrocino M. Codilla, Sr., requesting for a passage of a resolution authorizing the City Accountant to charge the amount of EIGHTY FIVE THOUSAND THREE HUNDRED FORTY-TWO PESOS & 30/100 (P85,342.30) against Supplemental Budgets No. 6 and 10 as refund of excess payment of GSIS Personal Share deductions for CY 1997-1998-1999 of aforementioned city officials;

WHEREAS, the City Budget Officer through 3rd Indorsement dated 08 December 2000 has recommended that authority be granted to the City Accountant to charge the above request against Supplemental Budget No. 6 and 10 - Due GSIS Arrearages;
