RESOLUTION NO. 2000-225

A RESOLUTION REQUIRING CERTAIN ACTS TO BE PERFORMED AND
THE SUBMISSION OF CERTAIN DOCUMENTS TO PROPER
AUTHORITIES CONCERNED PRIOR TO THE DOCKING OF ANY
VESSEL AT ANY ORMOC PORT (PUBLIC OR PRIVATE) TO PREVENT
THE SPREAD OF THE MALAYSIAN BLACK BUG.

WHEREAS, this august Body is in receipt of a letter dated 20
December 2000 from the Honorable City Mayor Eufrocino M. Codilla, Sr.,
requesting for the passage of a resolution requiring all vessels to be
subjected to boarding inspection by the Quarantine Task Force with
positive presence of Malaysian Black Bugs which have been seen in one of
the vessels docking at Ormoc Port;

WHEREAS, Sec. 458 par. 5 sub par. XII provides that:

"Section 458. Powers, Duties, Functions and Compensation -
a) The Sangguniang Panlungsod, as the legislative of the city,
shall enact ordinances, approve resolution and appropriate funds
for the General Welfare of the City and its inhabitants pursuant to
Section 16 of this code and in the proper exercise of the corporate
powers of the City as provided for under Section 23 of this code,
and shall:

X X X

(xii) Approve measures and adopt quarantine regulations to prevent
the introduction and spread of diseases;

WHEREAS, these Malaysian Black Bug if not given immediate action,
will cause 85-90% damage to our rice farms, hence, this request;

WHEREFORE, foregoing premises considered, on motion of City Councilor Jose C. Alfaro, Jr., Chairman, Committee on Natural Resources & Environmental Control, jointly seconded by City Councilors Mariano Y. Corro and Sotero M. Pepito; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution requiring certain acts to be performed and the submission of certain documents to proper authorities concerned prior to the docking of any vessel at any Ormoc Port (Public or Private) to prevent the spread of the Malaysian Black Bug specifically the following:

1. To be subjected to boarding inspection by the Quarantine Task Force to, among others check on the following:
 - a) If it has Malaysian Black Bug on board or among its cargoes and if found positive, to have the vessel fumigated/treated prior to docking in accordance with sub par. 2.
2. To require the ship captain or master of the vessel to submit the following documents:
 - a) Certification that said vessel has been sprayed by Pest Control Company under the supervision of the Plant Quarantine Officer and attested by the same that such has been properly performed especially if said vessel originated from Camiguin, Cotabato, Zamboanga, Davao, Palawan, Cebu & Bohol.
3. Show an itinerary of Travel (Voyage Memo)
4. Passenger & Cargo Manifest
5. To require all vessels to inform the Philippine Coast Guard, Ormoc Station prior to its arrival/docking while still 300 meters from port by radio or whatever means of communications for the purpose of boarding inspection by the Quarantine Task Force and other activities related thereto.
6. To require the submission of Plant Quarantine Clearance from places where Rice Black Bug and other quarantinable pests are found.
7. To submit other pertinent documents and perform other acts necessary for the protection of the community relative to the prevention of the Malaysian Black Bug from entering Ormoc City.

ADOPTED, December 21, 2000.

RESOLVED, FURTHER, to request other cities/municipalities with ports to do similar solutions.

RESOLVED, FURTHERMORE, to furnish copies of this resolution each to the Regional Director, Department of Agriculture, Region 8, Tacloban City; the Philippine Ports Authority, PPA, Tacloban City; the Honorable City Mayor of Ormoc, Eufrocino M. Codilla, Sr.; the Philippine Ports Authority, Ormoc City, the Philippine Maritime Police, Ormoc City, the Philippine Coast Guard, Ormoc City, Mrs. Corazon N. Esperanza, City Agricultural Services Officer, Ormoc City and other concerned, -in Ormoc City.
