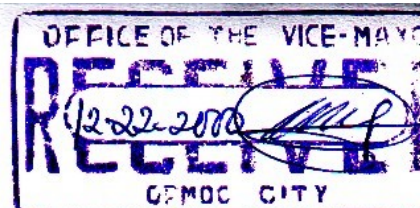
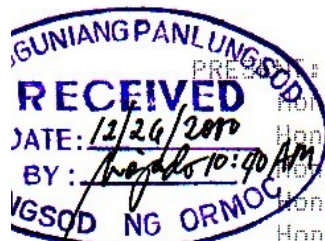

A RESOLUTION CREATING A TASK FORCE IN ORDER TO IMPLEMENT
RESOLUTION NO. 225 OF THIS SANGGUNIAN TO BE LEAD BY
MRS. CORAZON ESPERANZA, CITY AGRICULTURAL SERVICES
OFFICER AND TO BE COMPOSED OF THE PHILIPPINE COAST
GUARD, THE PHILIPPINE PORTS AUTHORITY, THE MARITIME
POLICE, THIS CITY AS MEMBERS.

WHEREAS, it has been reported that presence of Malaysian Black Bug
have been seen in one of the vessels docking at Ormoc Port and if not
given immediate action, these pests will cause 85-90% damage to our rice
farms;

WHEREAS, it is also imperative that everyday, vessels from
different places dock at the Ormoc Port for the delivery of passengers
and cargoes which include rice;

WHEREAS, it is in this sense that the Sangguniang Panlungsod ng
Ormoc opted to create a Task Force for purposes of subjecting to
boarding inspection all vessels which will dock at the Ormoc Port so as
to ensure the safety of its constituents and to prevent the spread of
diseases;

WHEREFORE, foregoing premises considered, on motion of City
Councilor Jose C. Alfaro, Jr., Chairman, Committee on Natural Resources
& Environmental Control, jointly seconded by City Councilor Fe S. Lladoc
& Dennis Y. Capuyan; be it

AND TO BE COMPOSED OF THE PHILIPPINE COAST GUARD, THE PHILIPPINE PORTS


