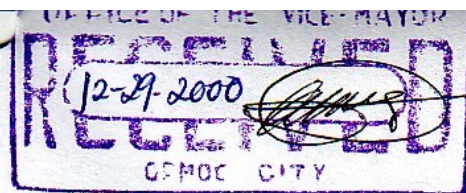
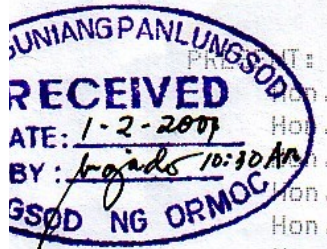

RESOLUTION NO. 2000-227

A RESOLUTION APPROVING TAX ORDINANCE NO. 01 SERIES OF 2000 OF THE BARANGAY COUNCIL OF CAMP DOWNES, THIS CITY, ENTITLED: "AN ORDINANCE IMPOSING TAXES ON STORES OR RETAILERS, SIGNS, SIGNBOARDS AND BILLBOARDS AND FOR OTHER PURPOSES".

WHEREAS, this Sanggunian is in receipt of Barangay Tax Ordinances No. 01 S. of 2000 of the Barangay Council of Camp Downes, this city, entitled, "AN ORDINANCE IMPOSING TAXES ON STORES OR RETAILERS, SIGNS, SIGNBOARD AND BILLBAORDS AND FOR OTHER PURPOSES."

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the aforecited Ordinance at issue (and all other ordinances of the Sangguniang Barangay in Ormoc City) is, by law, granted the Power of Review as to whether the said ordinances is consistent with law and city x x x ordinances; (Sec. 57, 1991 LGC);

WHEREAS, it is the observation of this august Body that the aforesaid ordinance has conformed to pertinent provisions of the Local Government Code, hence, reasonable and within the province of the Sangguniang Barangay of Camp Downes to legislate;
