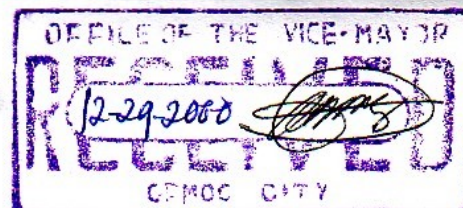
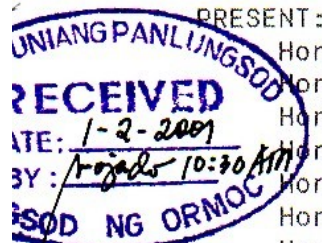

RESOLUTION NO. 2000-229

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EUFROCINO M. CODILLA, SR., TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES, REPRESENTED BY ITS PROVINCIAL ENVIRONMENT AND NATURAL RESOURCES OFFICER (PENRO) FELIPE S. CALUB, FOR THE ESTABLISHMENT OF A TEN (10) HECTARES MANGROVE PLANTATION IN BARANGAY NAUNGAN, ORMOC CITY.

WHEREAS, this august Body is in receipt of a letter dated 13 November 2000 from the Honorable City Mayor Eufrocino M. Codilla, Sr., requesting for a resolution authorizing him to sign for and in behalf of the City Government of Ormoc, a Memorandum of Agreement with the Department of Environment and Natural Resources for the establishment of ten (10) hectares mangrove plantation in barangay Naungan, Ormoc City;

WHEREAS, said Memorandum of Agreement states that the Local Government Unit (LGU) shares with Department of Environment and Natural Resources (DENR) the responsibility in the sustainable management and development of the forest resources within their territorial jurisdiction;

WHEREAS, it is necessary that the LGU should participate in the Community Based Forest Management Project (CBFMP) implementation especially in the information, education and communication campaign component of the program and provisions of alternative livelihood;



WHEREAS, this august Body has considered said request reasonable and beneficial, hence, same be accorded due course of action;

WHEREFORE, on motion of City Councilor Jose C. Alfaro, Jr., Chairman, Committee on Environment and Natural Resources, jointly seconded by City Councilors Claudio P. Larrazabal and Fe S. Lladoc; be it
