


CODILLA, SR., TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, A MEMORANDUM OF UNDERSTANDING WITH THE PROVINCIAL LOCAL GOVERNMENT UNIT OF LEYTE, REPRESENTED HEREIN BY GOVERNOR REMEDIOS L. PETILLA; THE PROVINCIAL LOCAL GOVERNMENT UNIT OF SOUTHERN LEYTE, REPRESENTED BY GOVERNOR ROSETTE Y. LERIAS; THE PROVINCIAL LOCAL GOVERNMENT UNIT OF SAMAR, REPRESENTED BY GOVERNOR JOSE A. WHEREAS, this Sanggunian is in receipt of 3rd Indorsement dated 12 December 2000 from the Honorable City Mayor Eufrocino M. Codilla, Sr., requesting for a passage of a resolution authorizing him to sign, for and in behalf of the City Government of Ormoc, a Memorandum of Understanding (MOU) on Establishment and Operationalization of the Regional Research, Development and Extension Network of Region VIII with

the different Provincial Local Government Units of Region VIII and the Department of Agriculture-Regional Field Unit No. 8, represented by Regional Director Cirilo R. Balagapo, Jr.;

WHEREAS, said Memorandum of Understanding (MOU) mentions of the Agricultural Modernization Act of 1997 (AFMA) which declares that the policy of the State is to promote science and technology as essential for national development and progress;

WHEREAS, Section 13 of AFMA mandates the DA, in consultation with the farmers and fisherfolk, the private sector, NGOs, people's organizations and appropriate government agencies and offices to formulate and implement a medium and long-term comprehensive Agriculture and Fisheries Modernization Plan to address food security, poverty alleviation and social equity, income enhancement and profitability, global competitiveness and sustainability;

WHEREAS, this Memorandum of Understanding (MOU) is an amendment of the MOU signed last May 11, 2000 at Tacloban City, between and among the some agriculture sectors and now it includes the new contracting parties, the Provincial and City Government Units as part of the Regional Research, Development and Extension (RD/E) Network, with the purpose of the following:

1. Plan and implement RDE activities prioritized in the Regional Integrated Research/Development and Extension Program (RIRDEP) in response to the needs of the farming communities;
2. Facilitate exchange of expertise, methodologies/tools, and results of the Research Development Extension (RDE) projects;
3. Effect sharing of resources and equipment by NETWORK MEMBERS specially in the pursuit of a common project;
4. Institutionalize strong linkage between the Network and the industry and the clientele of the agriculture sector;
5. Foster inter-agency coordination and collaborative undertakings in addressing the needs of the farming communities;

WHEREAS, the Sangguniang Panlungsod ng Ormoc has considered said request reasonable, hence, same be accorded with due course of action;

WHEREFORE, foregoing premises considered, on motion of City Councilor Claudio P. Larrazabal, Chairman, Committee on Agriculture, Fisheries and Agrarian Reform, severally seconded by City Councilors Mariano Y. Corro, Jose C. Alfaro, Jr., and Fe S. Lladoc; be it
