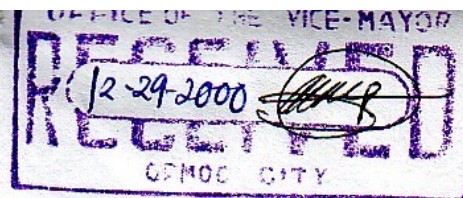
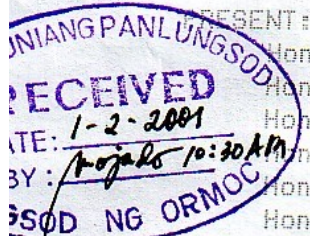

2000 OF BARANGAY DISTRICT 15 AND BARANGAY ESPERANZA, ORMOC CITY;


ADOPTED, December 28, 2000.
