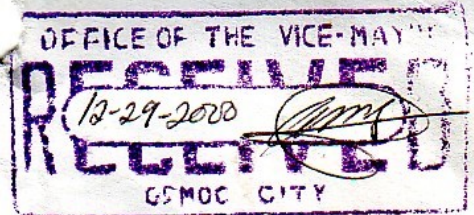

RESOLUTION NO. 2000-233

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR
EUFROCINO M. CODILLA SR., TO SIGN FOR AND IN BEHALF OF
THE CITY GOVERNMENT OF ORMOC, AS DONOR, A DEED OF
DONATION IN FAVOR OF THE DEPARTMENT OF EDUCATION,
CULTURE AND SPORTS, ORMOC CITY DIVISION, REPRESENTED BY
THE SCHOOLS DIVISION SUPERINTENDENT, VIOLETA M.
ALOCILJA, PH.D., CESO VI, AS DONEE, INVOLVING A PARCEL
OF LAND BEING PART OF LOT NO. 2227 CONTAINING AN AREA
OF 500 SQUARE METERS MORE OR LESS, SITUATED AT BARANGAY
COGON, THIS CITY, AS SITE OF THE DIVISION OFFICE,
PROVIDED THAT THE PROPERTY DONATED BE USED EXCLUSIVELY
FOR THE INTENDED PURPOSE AND SHOULD BE UTILIZED WITHIN
ONE YEAR FROM DATE OF EXECUTION OF THE DEED OF DONATION
OTHERWISE OWNERSHIP OF THE PROPERTY DONATED SHALL
REVERT TO THE CITY GOVERNMENT OF ORMOC.

WHEREAS, this august Body is in receipt of the 1st Indorsement
dated 26 April 2000 from the Office of the City Mayor re: letter of Dr.
Violeta M. Alocilja, Schools Division Superintendent, DECS, Ormoc City
requesting the Office of the City Mayor to identify the specific lot
which the City Government intends to donate to the Ormoc City Division
as site of the Division Office;

WHEREAS, in view of the availability of lot for the purpose, the
Honorable Members of this Sangguniang Panlungsod have reached out
consensus on following points:

- a) To follow the existing policy on giving 500 square meters
only to those asking for donation from the city
government.

- b) That in the Deed of Donation, the donee should be the DECS, Ormoc City Division.
- c) And further, that a provision should be incorporated in the Deed of Donation requiring the DECS, Ormoc City Division to construct a building within one (1) year from date of execution of the Deed of Donation and that the land donated should be used exclusively for the proposed DECS, Ormoc City Division Office, otherwise the ownership of the property donated shall revert to the City Government of Ormoc.

WHEREAS, said lot donated has the following Technical Description to wit:

"A parcel of land lot No. 2227-Part (Portion of Lot 2227). In the approved plan of Expropriated Lots Pcn-08-000008. Situated in the Barangay Cogon Combado (City Government Center), City of Ormoc, Island of Leyte. Bounded on the N.E., along line 2-3 by Lot 227-Part (10.00 m. road); on the S.E., along line 3-4 by Lot 2227-Part (Tennis Court), on the N.W., along line 1-2 by Lot 2227-Part, beginning at a point marked "1" on plan, being S. 89°W., 257.18 meters from BBM. No. 2., Ormoc Cadastre;

thence N. 76 deg. 33'E 31.96 m. to point 2;
thence S. 25 deg. 22'E 15.99 m. to point 3;
thence S. 76 deg. 33'W 31.96 m. to point 4;
thence N. 25 deg. 22'W 15.99 m. to point of

the beginning. Containing an area of FIVE HUNDRED (500) SQUARE METERS, more or less. All points referred to are indicated are bearings true.

WHEREFORE, foregoing premises considered, on motion of City Councilor Mariano Y. Corro, Vice Chairman, Committee on Laws & Ordinances, duly seconded by City Councilor Claudio P. Larrazabal; be it

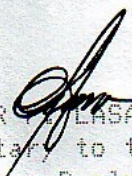

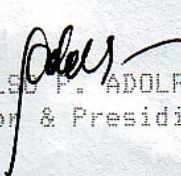
