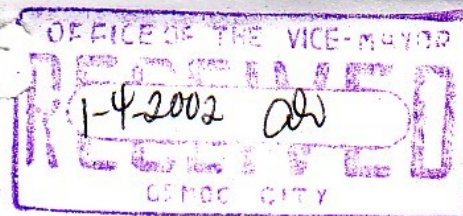
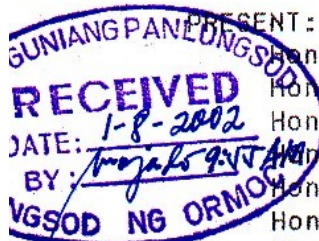



ADOPTED, January 03, 2002.


