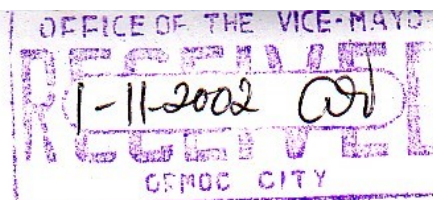
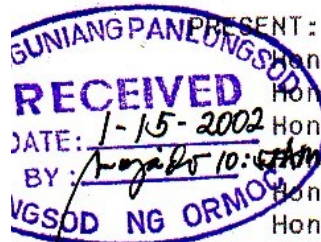

GOVERNMENT CODE OF 1991 OF THE RURAL DEVELOPMENT INSTITUTE-LEYTE, INC.;


