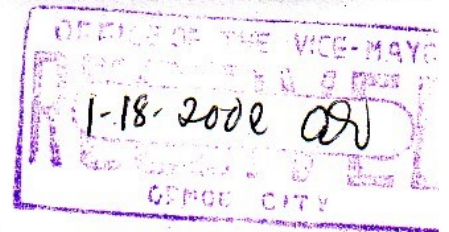

ADOPTED, January 17, 2002.




