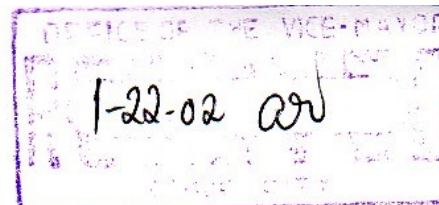

RESOLUTION NO. 2002-008

A RESOLUTION AMENDING RULE II SECTION 1 SUB PARAGRAPH  
(g) OF THE INTERNAL RULES OF THE 9TH SANGGUNIANG  
PANLUNGSOD.

WHEREAS, the present Internal Rules and Procedures of the 9th  
Sangguniang Panlungsod need revision in order to conform to the  
immediate needs and actions of this Sanggunian;

WHEREAS, in the maintenance of good order in sanggunian, fast and  
effective deliberation and passage of ordinances and resolutions is  
effective in order for the proper discharge of legislative function  
pursuant to Rule 6, Section 4, Par. A of Republic Act 6713;

WHEREAS, upon proper deliberation and consideration among the  
members of this Sanggunian, Rule II, Section 1, sub par. (g) be  
considered for amendment:

"(g) He shall sign and, whenever necessary, authenticate  
all orders, acts, memoranda, warrants, order of arrest,  
subpoenas, and proceedings of the Sanggunian;"

Amended to read as follows:

"(g) He shall sign and act within 15 working days from  
receipt minutes, ordinances, resolutions, communications,  
whenever necessary, authenticate all orders, acts, memoranda,  
warrants, order of arrest, subpoena and proceedings of the  
sanggunian."
