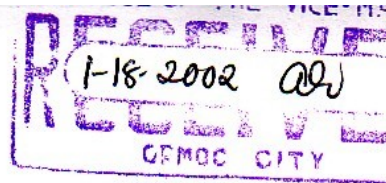
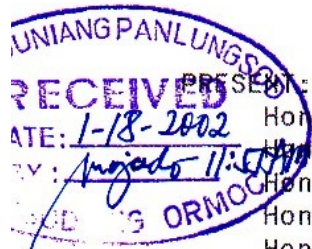

RESOLUTION NO. 2002-009

A RESOLUTION AMENDING RULE IV SECTION 1 OF THE INTERNAL
RULES OF THE 9TH SANGGUNANG PANLUNGSOD BY CREATING A
NEW COMMITTEE WHICH SHALL BE CALLED A COMMITTEE ON
NATIONAL AND FOREIGN FUNDED PROJECTS.

WHEREAS, the City Government of Ormoc is going to create a
committee to be known as Committee on National & Foreign Funded Projects
which will be headed by a City Councilor authorized to represent foreign
assisted projects in the form of grant, assistance and soft loans;

WHEREAS, it can be recalled that Ormoc City was once a recipient of
foreign assisted project, the JICA Flood Mitigation Project which was
approved and already been completed;

WHEREAS, in order to be granted similar future assistance it is but
necessary to have a committee on such projects so that future projects
can be properly evaluated and assessed;

WHEREFORE, foregoing premises considered, on motion of City
Councilor Demosthenes F. Tugonon, Chairman, Committee on Internal Rules,
jointly seconded by City Councilors Greogorio A. Yrastorza, Jr. and
