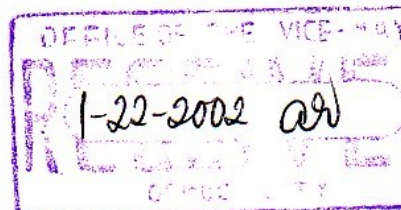
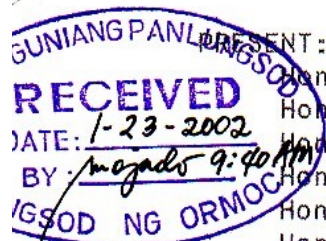

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR CARMELO J. LOCSIN TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC A CONTRACT FOR CONSULTANCY SERVICES FOR THE FEASIBILITY STUDY AND MASTER PLANNING FOR THE REHABILITATION/IMPROVEMENT/EXPANSION OF THE WATERWORKS PROJECT FOR THE CITY OF ORMOC WITH ASIATIC CONSULTANTS & ASSOCIATES.

WHEREAS, this august Body is in receipt of a communication dated 10 December 2001 from the Honorable City Mayor Carmelo J. Locsin, requesting for an urgent favorable action on the implementation of the Memorandum of Agreement (MOA) between the City Government of Ormoc represented by the Honorable City Mayor Carmelo J. Locsin and Asiatic Consultants and Associates represented by its Managing Partner, Dr. Rafael T. Apostol, PhD;

WHEREAS, said Memorandum of Agreement (MOA) states that the City of Ormoc recognizes the urgent necessity of rehabilitating, improving and expanding the City Waterworks System to provide adequate and continuous water supply to its growing population;

WHEREAS, the City of Ormoc is in need of Technical Consultancy services for feasibility study and master planning for the implementation of the above project;

WHEREAS, this august Body has considered said request reasonable and beneficial, hence, same is accorded due course of action;
