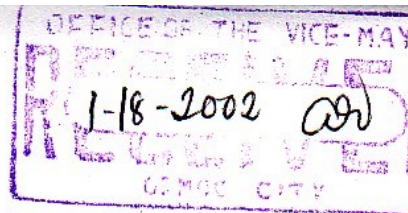
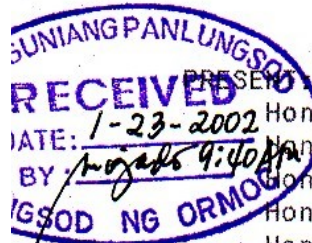

by City Councilor Eduardo P. Tan; be it


RESOLVED, to pass a resolution APPROVING THE DROPPING/SUBSTITUTION

ADOPTED, January 17, 2002.


RESOLVED, FURTHER, to furnish copies of this resolution each to His
