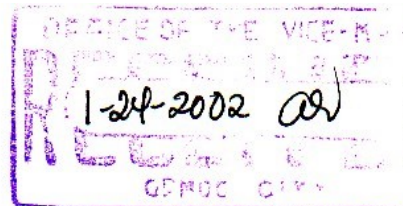


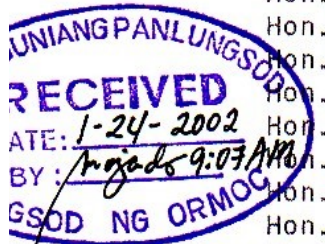

RESOLUTION NO. 2002-017

A RESOLUTION OVERRIDING THE VETO OF THE HONORABLE CITY
MAYOR ON CERTAIN ITEMS ON APPROPRIATION ORDINANCE NO.
2002-001 AND LIKEWISE AFFIRMING THOSE VETOED ITEMS ON
SAID APPROPRIATION ORDINANCE.

WHEREAS, this august Body is in receipt of a letter dated 11
January 2002 from the Honorable City Mayor informing the same that there
are certain items on Appropriation Ordinance No. 2002-001 that must be
vetoed as they are either ultra vires or prejudicial to the public
welfare;

WHEREAS, after deliberation, the following items were overridden:

Items No. 1 & 9 are health services which is one of the priorities
of the Honorable City Mayor while Item No. 6, Aid to Tourism Council is
in the interest of public welfare.

Item No. 11, Aid to Ormoc District Hospital was reduced considering
that being as such, guidelines must be issued so that the purpose of
said aid will not be defeated.

Item 12 which reduced the budget for the aid to the Office of the Clerk of Court. The Office of the Clerk of Court is a National Office and the amount of P30,000.00 is only for their supplies and materials.

Item 14, Aid to the Anti-Drug Abuse Council (CADAC), the amount was reduced to P1 Million.

No record from Police Department which could show as to how much of the crimes committed in this city are drug related. Committee on Finance gave the Police ample time to furnish data but still no data was shown.

Page 160 Item No. 159. These grants, subsidies are necessary for the efficient functioning of the Councilors of the 9th Sangguniang Panlungsod including its capital outlay specially on the information technology and in the Service Vehicle. It will not be solely for the use of individual City Councilors, but for the use of the Sanggunian, as a whole.

Provision for Senior Citizens have been increased because these are poor indigent people and they need our attention and assistance.

The Country Program for children was also increased as well as Aid to Ormoc City Livelihood Center inspite of the absence of these items in the budget, same were included because the 9th Sangguniang Panlungsod was thinking of our fellow Ormocanons that are in the lower income bracket.

WHEREAS, for purposes of making the Annual Budget operative, those items not overridden shall be affirmed or maintained;

WHEREFORE, foregoing premises considered, on motion of City Councilor Rafael C. Omega, Jr., Chairman, Committee on Finance, duly seconded by City Councilor Nepomuceno P. Aparis I; be it


RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution OVERRIDING THE VETO OF THE HONORABLE CITY MAYOR ON CERTAIN ITEMS ON APPROPRIATION ORDINANCE NO. 2002-001 AND LIKEWISE AFFIRMING THOSE VETOED ITEMS ON SAID APPROPRIATION ORDINANCE;
