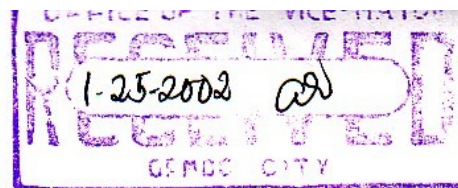

RESOLUTION NO. 2002-023

A RESOLUTION DECLARING IN "STATE OF CALAMITY" CERTAIN
AREAS IN THE CITY OF ORMOC AFFECTED BY TYPHOON "NANANG"
ON NOVEMBER 7, 2001 AND THE MALAYAN BLACK BUG.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 03
January 2002 from the Office of the City Mayor, this city, re: Ormoc
CDCC requesting this august Body to declare certain areas in this city
in a "State of Calamity";

WHEREAS, certain areas in Ormoc City were greatly damaged by
Typhoon "Nanang" last November 7, 2001;

WHEREAS, Brgy. Macabug and other areas also suffered damages to
crops amounting millions of pesos affected by the Malayan Black Bug;

WHEREAS, the authority to determine and declare an area or a
portion thereof as calamity area is vested solely on the local
sanggunian concerned as provided for by Sec. 1 of Republic Act No. 8185,
entitled: "AN ACT AMENDING SECTION 324 (d) OF R.A. NO. 7160, OTHERWISE
KNOWN AS THE LOCAL GOVERNMENT CODE OF 1991", dated June 11, 1996 and
quoted hereunder as follows:

"Sec. 1. Section 324 (d) of Republic Act No. 7160 is
hereby amended to read as follows:

(d) Five percent (5%) of the estimated revenue from
regular sources shall be set aside as annual lump sum
appropriations for the relief, rehabilitation,
reconstruction and other works or services in connection

with calamities which may occur during the budget year, Provided, however, that such fund shall be used only in the area or portion thereof of the local government or other areas affected by a disaster or calamity, as determined and declared by the local sanggunian concerned";

WHEREAS, the Sangguniang Panlungsod ng Ormoc, mindful of the plight of its constituents has considered said request reasonable, hence, same must be accorded due course of action;

WHEREFORE, foregoing premises considered, on motion of City Councilor Nepomuceno P. Aparis I, Chairman, Committee on Laws & Ordinances, jointly seconded by City Councilors Porferia Ma. Codilla & Ruvinieo E. Mendola; be it
