

RESOLUTION NO. 2002-024

RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR CARMELO LOCSIN TO RELEASE THE AMOUNT OF ONE MILLION THREE HUNDRED THOUSAND PESOS (\$1,300,000.00) TO THE CITY SOCIAL WELFARE AND DEVELOPMENT OFFICE TO BE CHARGED FROM THE CALAMITY FUND FOR THE RELIEF, REHABILITATION AND RECONSTRUCTION OF THOSE AREAS DECLARED UNDER "STATE OF CALAMITY" AFFECTED BY TYPHOON "NANANG" ON NOVEMBER 7, 2001 AND THE MALAYAN BLACK BUG.

WHEREAS, this Sanggunian passed Resolution No. 2002-023 dated 24 January 2002, entitled: "A RESOLUTION DECLARING IN "STATE OF CALAMITY" CERTAIN AREAS IN THE CITY OF ORMOC AFFECTED BY TYPHOON "NANANG" ON NOVEMBER 7, 2002 AND THE MALAYAN BLACK BUG";

WHEREAS, Sec. 1 of R.A. No. 8185, entitled: "AN ACT AMENDING SECTION 324(d) of R.A. NO. 7160, OTHERWISE KNOWN AS THE LOCAL GOVERNMENT CODE OF 1991", provides:

"Sec. 1. Section 324(d) of R.A. No. 7160 is hereby amended to read as follows:

(d) Five percent (5%) of the estimated revenue from regular sources shall be set aside as annual lump sum appropriations for the relief, rehabilitation, reconstruction and other works or services in connection with calamities which may occur during the budget year, Provided, however, that such fund shall be used only in the area or portion thereof of the local government or other areas affected by a disaster or calamity, as determined and declared by the local sanggunian concerned";

WHEREAS, foregoing premises considered on motion of City Councilor Rafael C. Omega, Jr., Chairman, Committee on Finance, jointly seconded by Fe S. Lladoc and Fernando P. Parrilla; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR CARMELO J. LOCSIN TO RELEASE THE AMOUNT OF ONE MILLION THREE HUNDRED THOUSAND PESOS (P1,300,000.00) TO THE CITY SOCIAL WELFARE AND DEVELOPMENT OFFICE TO BE CHARGED FROM THE CALAMITY FUND FOR THE RELIEF, REHABILITATION AND RECONSTRUCTION OF THOSE AREAS DECLARED UNDER "STATE OF CALAMITY" AFFECTED BY TYPHOON "NANANG" ON NOVEMBER 7, 2001 AND THE MALAYAN BLACK BUG;

ADOPTED, January 24, 2002.
