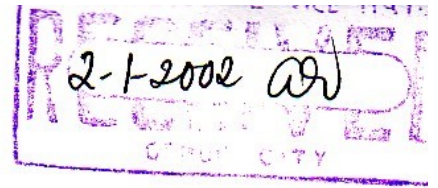

RESOLUTION NO. 2002-025

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR CARMELO  
J. LOCSIN TO RELEASE THE AMOUNT OF FIVE HUNDRED FORTY  
EIGHT THOUSAND NINE HUNDRED FIFTY PESOS (P548,950.00)  
FROM THE FIVE PERCENT (5%) CALAMITY FUND FOR THE  
REHABILITATION OF RICE FARMS DAMAGED BY THE MALAYAN  
RICE BLACK BUG IN BARANGAY MACABUG AND FOR THE VICTIMS  
OF TYPHOON "NANANG".

WHEREAS, this august Body is in receipt of Ormoc City Disaster  
Coordinating Council (OCDCC) Resolution No. 02 s. 2001 entitled, "A  
RESOLUTION REQUESTING THE HONORABLE SANGGUNIANG PANLUNGSOD FOR THE  
RELEASE OF P548,950.00 AS TO BE TAKEN FROM THE 5% CALAMITY FUND OF CY  
2001 FOR THE REHABILITATION OF RICE FARMS DAMAGED BY THE MALAYAN RICE  
BLACK BUG IN BARANGAY MACABUG AND THE VICTIMS OF TYPHOON "NANANG" AS PER  
REPORT GIVEN BY THE CITY AGRICULTURAL SERVICES OFFICE";

WHEREAS, said aforementioned areas have been declared in "STATE OF  
CALAMITY" through SP Resolution No. 2002-023 dated 24 January 2002 and  
that the basis for declaring the same is quoted hereunder as follows:

Sec. 1 of R.A. No. 8185, entitled: "AN ACT AMENDING  
SECTION 324(d) of R.A. NO. 7160, OTHERWISE KNOWN AS THE LOCAL  
GOVERNMENT CODE OF 1991", provides:



"Sec. 1. Section 324(d) of R.A. No. 7160 is hereby amended to read as follows:

(d) Five percent (5%) of the estimated revenue from regular sources shall be set aside as annual lump sum appropriations for the relief, rehabilitation, reconstruction and other works or services in connection with calamities which may occur during the budget year, Provided, however, that such fund shall be used only in the area or portion thereof of the local government or other areas affected by a disaster or calamity, as determined and declared by the local sanggunian concerned";

WHEREFORE, foregoing premises considered, on motion of City Councilor Rafael C. Omega, Jr., Chairman, Committee on Finance, duly seconded by City Councilor Gregorio A. Yrastorza, Jr.; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR CARMELO J. LOCSIN TO RELEASE THE AMOUNT OF FIVE HUNDRED FORTY EIGHT THOUSAND NINE HUNDRED FIFTY PESOS (P548,950.00) FROM THE FIVE PERCENT (5%) CALAMITY FUND FOR THE REHABILITATION OF RICE FARMS DAMAGED BY THE MALAYAN RICE BLACK BUG IN BARANGAY MACABUG AND FOR THE VICTIMS OF TYPHOON "NANANG";

ADOPTED, January 31, 2002.
