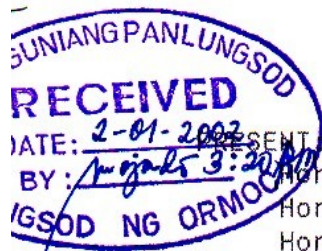

WHEREAS, this august Body is in receipt of 1st Indorsement dated 03
January 2002 from the Honorable City Mayor Carmelo J. Locsin re: Cities
Sisterhood Covenant between the City of Ormoc represented by City Mayor
Carmelo J. Locsin and Baguio City, represented by Atty. Virgilio F.
Bautista;
