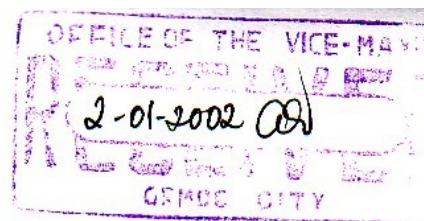

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR CARMELO
J. LOCSIN TO NEGOTIATE AND ENTER INTO CONTRACT FOR THE
PURCHASE OF LOTS FOR THE PROPOSED SLAUGHTERHOUSE
PROJECT IN BARANGAY MACABUG, ORMOC CITY. PROVIDED THAT
THE LAND REFORM PROGRAM IS COMPLIED WITH.

WHEREAS, this august Body is in receipt of a letter dated 14
November 2001 from the Honorable City Mayor Carmelo J. Locsin earnestly
and urgently requesting for authority to negotiate and enter into
contract for the purchase of lots for the proposed slaughterhouse
project with pertinent documents attached in support thereof;

WHEREAS, the City Appraisal Committee through Resolution No. 2002-
01 dated 03 January 2002 has appraised lots #11476, and 11477 covered by
OCT # 530 and lot # 11479 covered by TCT # 22653 all situated at
Barangay Macabug, this city at ₱90.00 per sq. meter;

WHEREAS, after a thorough site inspection and re-evaluation
conducted, the City Planning and Development Office finds the properties
of Mariano Tan to be the most suitable site for said project;

WHEREAS, this august Body has conformed to the findings of the City
Planning & Development Office, hence, said request be accorded the
necessary course of action;


