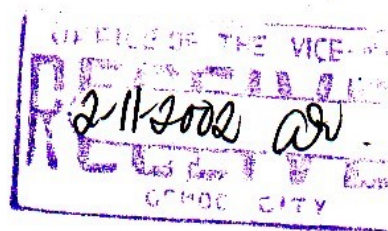
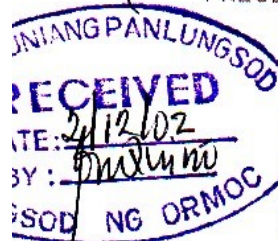

RESOLUTION NO. 2002-028

A RESOLUTION AUTHORIZING THE CITY ACCOUNTANT TO CHARGE
THE AMOUNT OF TWENTY SIX THOUSAND NINE HUNDRED TWENTY
EIGHT PESOS & 32/100 (P26,928.32) AGAINST THE PROVISION
FOR PRIOR YEARS OBLIGATIONS, A NON-OFFICE ITEM OF THE
ANNUAL BUDGET FOR CY 2002, FOR THE PAYMENT OF UNPAID
ACCOUNTABLE FORMS WITH THE BUREAU OF INTERNAL REVENUE.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 25
January 2002 from Mr. Bienvenido A. Matiga, Acting Secretary to the
Mayor, a letter of Mr. Rene C. Fermin, ICO-City Treasurer's Office,
requesting for an appropriation in the amount of TWENTY SIX THOUSAND
NINE HUNDRED TWENTY EIGHT PESOS AND 32/100 (P26,928.32) for payment of
unpaid accountable forms with the Bureau of Internal Revenue;

WHEREAS, the City Budget Officer, through 4th Indorsement dated 5
February 2002 has recommended that authority be granted the City
Accountant to charge above obligation against the Provision for Prior-
Years Obligation, a non-office account under CY 2002 Annual Budget;

WITH THE BUREAU OF INTERNAL REVENUE;
