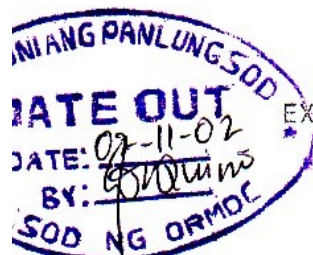
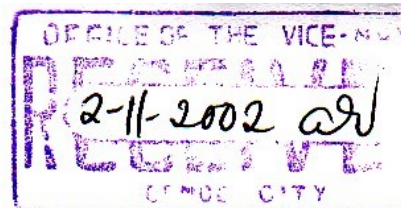
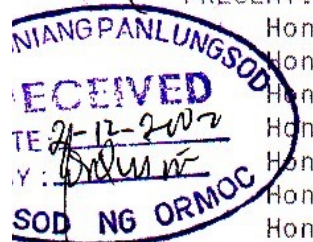

A RESOLUTION REQUESTING THE HONORABLE CITY MAYOR OF CEBU, MAYOR TOMAS OSMEÑA TO DONATE HOSPITAL BEDS & OTHER HOSPITAL EQUIPMENT TO ORMOC CITY AND REQUESTING FURTHER THE HONORABLE VICE MAYOR MICHAEL RAMA, PRESIDING OFFICER OF THE SANGGUNIANG PANLUNGSOD AND THE HONORABLE CEBU CITY COUNCILORS TO ALLOW/AUTHORIZE THE HONORABLE CITY MAYOR TOMAS OSMEÑA TO DONATE THE ABOVE-MENTIONED HOSPITAL BEDS & OTHER HOSPITAL EQUIPMENT.

WHEREAS, Ormoc City being one of the growing cities in Eastern Visayas is indeed doing its best to cope up with the needs of its constituents especially in delivering the necessary basic services in the city and to the far-flung barangays;
