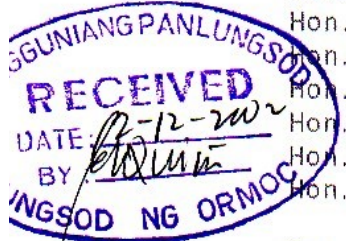
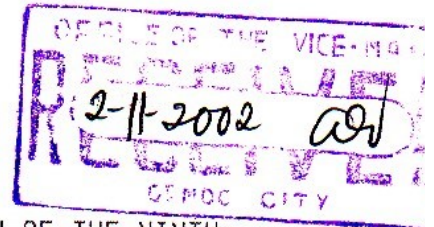

A RESOLUTION EARNESTLY REQUESTING THE MANAGEMENT OF PHILIPPINE NATIONAL OIL COMPANY (PNOC) TO GIVE PRIORITY IN THE HIRING OF EMPLOYEES TO APPLICANTS WHO ARE RESIDENTS OF ORMOC CITY FOR THEIR TONGONAN GEOTHERMAL PROJECTS.

WHEREAS, the Philippine National Oil Company (PNOC) Geothermal Project at Barangay Tongonan, Ormoc City is on-going and as such the need to hire laborers/workers for said project exists;

WHEREAS, for being a government-owned and controlled corporation like PNOC, it is the policy of the National Government to utilize local labor in said projects considering that the National wealth they are developing is located in Ormoc, so it is but proper also to hire workers in our locality;

WHEREAS, in fairness also to those local applicants who are qualified, this august Body believes that the same be given preference, hence, this request;
