

RESOLUTION NO. 2002-039

RESOLUTION FARMESTLY REQUESTING CONGRESS TO ENACT A LAW SETTING FOR NEW DATES FOR THE GENERAL REGISTRATION OF THE KATIPUNAN NG MGA KABATAAN SPECIFICALLY ON APRIL 1-2002, AFTER THE HOLY WEEK AND DURING THE VACATION DURING WHICH THE YOUTH WILL BE AVAILABLE TO PARTICIPATE IN CONNECTION WITH THE SCHEDULED MAY 2002 SANGGUNIANG KABATAAN ELECTIONS AND PROVIDING FUNDS THEREFOR.

WHEREAS, it can be recalled that the members of the Katipunan ng mga Kabataan had their general registration on December 10-26, 2001 pursuant to COMELEC Resolution No. 4713 in connection with the scheduled May 2002 SK Election;

WHEREAS, the result of the Kabataan general registration was that few among the youth aged 15-21 were able to register and some were not registered at all notwithstanding the fact that they were already in areas designated for registration because same were closed at five o'clock in the afternoon and that said COMELEC Resolution No. 4713 was issued only on December 6, 2001 four days before the onset of the general registration;

WHEREAS, the low turn out of the general registration is mostly attributable to the lack of information dissemination, insufficient number of application forms and the fact that registration were held in city and municipal halls which are inconvenient and/or inaccessible to those youth residing in the far-flung barangays;

WHEREAS, to correct the flaws which were attendant in the previous registration, it is important to set new dates for the same, that adequate supply of registration forms must be supplied and the designation of accessible areas for said purpose;

WHEREFORE, foregoing premises considered, on motion of City Councilor Chiqui B. Labagala, SK Federation President, duly seconded by City Councilor Rafael C. Omega, Jr.; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution EARNESTLY REQUESTING CONGRESS TO ENACT A LAW SETTING FOR NEW DATES FOR THE GENERAL REGISTRATION OF THE KATIPUNAN NG MGA KABATAAN SPECIFICALLY ON APRIL 1-5, 2002, AFTER THE HOLY WEEK AND DURING THE VACATION DURING WHICH THE YOUTH WILL BE AVAILABLE TO PARTICIPATE IN CONNECTION WITH THE SCHEDULED MAY 2002 SANGGUNIANG KABATAAN ELECTIONS AND PROVIDING FUNDS THEREFOR;
