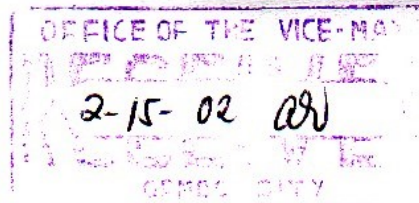
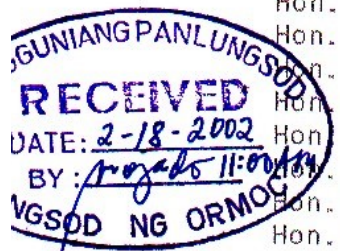

PROJECTS;


