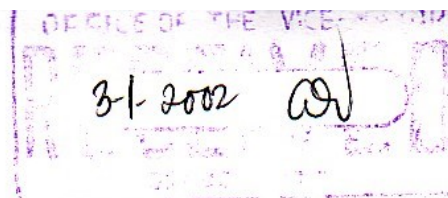

RESOLUTION NO. 2002-051

A RESOLUTION APPROVING ORDINANCE NO. 2001-00 OF THE  
BARANGAY COUNCIL OF BARANGAY JUATON, ENTITLED: "AN  
ORDINANCE PROHIBITING RESIDENTS OF THIS BARANGAY FROM  
THE INDISCRIMINATE THROWING OF GARBAGE AND/OR  
UNSANITARY DISPOSAL OF ANY WASTE MATERIALS, INCLUDING  
THOSE WASTES DERIVED FROM HOG AND POULTRY RAISING,  
PROVIDING PENALTIES IN VIOLATION THEREOF".

WHEREAS, this Sanggunian is in receipt of Ordinance No. 2001-00 of  
Barangay Juaton, this city, entitled: "AN ORDINANCE PROHIBITING  
RESIDENTS OF THIS BARANGAY FROM THE INDISCRIMINATE THROWING OF GARBAGE  
AND/OR UNSANITARY DISPOSAL OF ANY WASTE MATERIALS, INCLUDING THOSE  
WASTES DERIVED FROM HOG AND POULTRY RAISING, PROVIDING PENALTIES IN  
VIOLATION THEREOF";

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the  
aforecited ordinance at issue (and all other ordinances of the  
Sangguniang Barangay in Ormoc City), is by law, granted the Power of  
Review as to whether the said ordinance is consistent with law and city  
X X X ordinances; (Sec. 57, 1991 LGC)

WHEREAS, it is the observation of this august Body through the  
representation of the Honorable Chairman, Committee on Laws and  
Ordinances that the aforesaid ordinance has conformed to pertinent  
provisions of the Local Government Code, hence, reasonable and within  
the province of the Sangguniang Barangay of Brgy. Juaton to legislate;



WHEREFORE, foregoing premises considered, on motion of City Councilor Nepomuceno P. Aparis I, Chairman, Committee on Laws and Ordinances jointly seconded City Councilors Demosthenes F. Tugonon and Fe S. Lladoc; be it



ADOPTED, February 28, 2002.


