RESOLUTION APPROVING ORDINANCE NO. 2001-00 OF THE BARANGAY COUNCIL OF BARANGAY JUATON, ENTITLED: "AN ORDINANCE PROHIBITING RESIDENTS OF THIS BARANGAY FROM AND/OR GARBAGE OF INDISCRIMINATE THROWING UNSANITARY DISPOSAL OF ANY WASTE MATERIALS, INCLUDING THOSE WASTES DERIVED FROM HOG AND POULTRY RAISING, PROVIDING PENALTIES IN VIOLATION THEREOF".

WHEREAS, this Sanggunian is in receipt of Ordinance No. 2001-00 of Juaton, this city, entitled: "AN ORDINANCE PROHIBITING Barangay RESIDENTS OF THIS BARANGAY FROM THE INDISCRIMINATE THROWING OF GARBAGE AND/OR UNSANITARY DISPOSAL OF ANY WASTE MATERIALS, INCLUDING THOSE WASTES DERIVED FROM HOG AND POULTRY RAISING, PROVIDING PENALTIES IN VIOLATION THEREOF";
