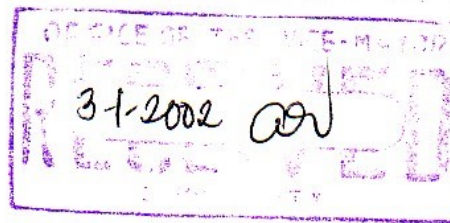

by City Councilor Ruviniu E. Mendola; be it


RESOLVED, to pass a resolution APPROVING THE APPLICATION FOR

ADOPTED, February 28, 2002.


RESOLVED, FURTHER, to furnish copies of this resolution each to His
