

A RESOLUTION AUTHORIZING THE CITY ACCOUNTANT TO CHARGE TO PRIOR YEAR'S OBLIGATIONS, A NON-OFFICE ITEM OF THE ANNUAL BUDGET FOR CY 2002 THE AMOUNT OF FOUR HUNDRED SEVENTY FIVE THOUSAND FIVE HUNDRED EIGHTY FIVE PESOS & 50/100 (\$475,585.50) FOR PAYMENT OF MORTGAGE FEE DUE TO THE REGISTER OF DEEDS AND THE BUREAU OF INTERNAL REVENUE ON THE CITY'S MARKET LOAN WITH LAND BANK OF THE PHILIPPINES.

WHEREAS, this Sanggunian is in receipt of the letter dated 17 September 2001 from Mr. Rene C. Fermin, ICO-City Treasurer, requesting for an authority to charge against Prior Year's Obligation of Annual Budget 2001 the unpaid mortgage fee due to the Register of Deeds and the Bureau of Internal Revenue on the City's Market Loan with the Land Bank of the Philippines (LBP) amounting to FOUR HUNDRED SEVENTY FIVE THOUSAND FIVE HUNDRED EIGHTY FIVE PESOS & 50/100 (\$475,585.50);
