

A RESOLUTION AUTHORIZING THE CITY ACCOUNTANT TO CHARGE THE AMOUNT OF ONE HUNDRED THIRTY NINE THOUSAND TWENTY SIX PESOS (#139,026.00) AGAINST CURRENT APPROPRIATION-OUTLAY FOR LEAVE CREDITS OF THE SANGGUNIANG PANLUNGSOD FOR PAYMENT OF TERMINAL LEAVE OF FORMER CITY COUNCILOR JOSE C. ALFARO, JR..

WHEREAS, this Sanggunian is in receipt of letter dated 26 February 2002 from Jose C. Alfaro, Jr., former SP Member of the 8th Sangguniang Panlungsod ng Ormoc, requesting for a resolution authorizing the City Accounting Office to act relative to his claim for Terminal Leave payment amounting to One Hundred Thirty Nine Thousand Twenty Six Pesos (P139,026.00) which said office failed to obligate in the CY 2001 Annual Budget;

WHEREAS, the City Budget Officer, through 3rd Indorsement dated 4 March 2002 has recommended that authority be granted the City Accountant to charge the above request against the current appropriation-outlay for Leave Credits- of the Sangguniang Panlungsod;

WHEREAS, the City Treasurer through 5th Indorsement dated 04 March 2002 has certified that fund is available subject however to accounting and auditing rules and procedures;
