

GILBERTO CABEROS OF THE CITY ENGINEER'S OFFICE COVERING THE MONTHS OF NOVEMBER & DECEMBER 2001.

WHEREAS, this Sangguniang is in receipt of 1st Indorsement dated 7 February 2002 from Mr. Bienvenido A. Matiga, Acting Secretary to the Mayor, a letter of Engr. Wilfredo A.
