

RESOLUTION AUTHORIZING THE CITY ACCOUNTANT TO CHARGE THE AMOUNT OF TWENTY THOUSAND PESOS (\$20,000.00) AGAINST THE 5% BUDGETARY RESERVE, A NON-OFFICE ITEM UNDER THE CY 2002 ANNUAL BUDGET AS FINANCIAL ASSISTANCE TO THE FLOOD VICTIMS TO THE MUNICIPALITY OF MAHINOG, PROVINCE OF CAMIGUIN PARTICULARLY BARANGAY HUBANGON.

WHEREAS, this august Body is receipt of a letter dated January 03, 2002 from the Municipal Mayor of Mahinog, Province of Camiguin, requesting for financial assistance for the flood victims of the town of Mahinog, particularly Barangay Hubangon of said province;

WHEREAS, the Honorable City Mayor of Ormoc, Camelo J. Locsin has approved the amount of TWENTY THOUSAND PESOS (P20,000.00) as financial assistance to said barangay;

WHEREAS, the City Budget Officer through 4th Indorsement dated 11 February 2002 has recommended that the amount of TWENTY THOUSAND PESOS (\$20,000.00) be sourced from the 5% Budgetary Reserve, a non-office item under the CY 2002 Annual Budget;
