

A RESOLUTION AUTHORIZING THE CITY ACCOUNTANT TO CHARGE THE OUTSTANDING ACCOUNTS ON STREET ILLUMINATION AND POWER CONSUMPTION OF VARIOUS PUBLIC BUILDINGS IN THE AMOUNT OF THREE HUNDRED SEVENTY FOUR THOUSAND FOUR HUNDRED THIRTEEN PESOS & 38/100 (\$374,413.38) AGAINST THE CURRENT APPROPRIATION OF THE OFFICE OF THE GENERAL SERVICES AS FOLLOWS:

1. STREET ILLUMINATION & LIGHTING - P282,462.18
2. ILLUM. & POWER-PUB. BLDGS. - 91,951.20

WHEREAS, this Sanggunian is in receipt of a letter dated 19 February 2002 from Mr. Angelo I. Roman, City General Services Officer, requesting this august Body to pass a resolution authorizing the City Accountant to charge against prior year's obligations the total amount of THREE HUNDRED SEVENTY FOUR THOUSAND FOUR HUNDRED THIRTEEN PESOS & 38/100 (\$374,413.38) for payment of the outstanding account on street illumination and power consumption of various public buildings and

street lights;
