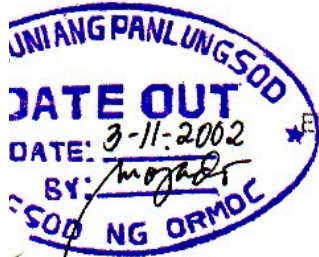
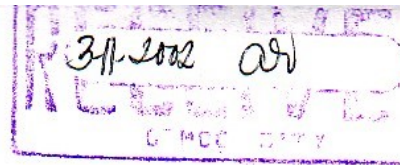
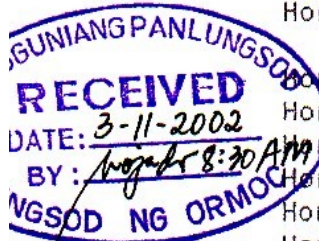

ADOPTED, March 07, 2002.


