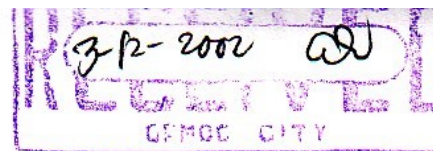
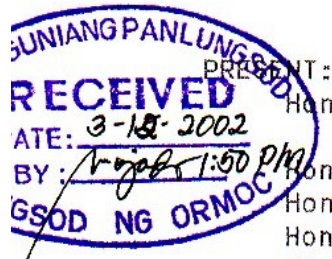

RESOLUTION NO. 2002-068

A RESOLUTION EARNESTLY REQUESTING THE HONORABLE SECRETARY, PRESIDENTIAL MANAGEMENT STAFF, FOR FUNDING SUPPORT FROM HER EXCELLENCY, PRESIDENT GLORIA MACAPAGAL-ARROYO FOR THE CONSTRUCTION OF FARM TO MARKET ROAD FROM BARANGAY MANLILINAO, TO BARANGAY MONTERICO, ORMOC CITY.

WHEREAS, the City Government of Ormoc, in its effort to uplift the living conditions of its constituents has considered the construction of a farm to market road from Barangay Manlilinao to Barangay Monterico, this city, thus, requesting the Honorable Secretary Presidential Management Staff for funding support from Her Excellency, Gloria Macapagal-Arroyo;
