

SUPPORTING RESOLUTION NO. 2002-19 OF THE RESOLUTION SANGGUNIANG PANLUNGSOD OF GINGOOG CITY REQUESTING THE PHILIPPINE CONGRESS AND SENATE TO PASS A BILL THE EFFECT OF MAXIMIZING THE USE OF COCO FUND OUT COTO LEVY TO SUBSIDIZE THE PRICE OF COPRA.

WEREAS, this august Body is in receipt of Resolution No. 2002-19 of the Sangguniang Panlungsod of Gingoog City entitled: A RESOLUTION REQUESTING THE HONORABLE CHAMBERS OF THE PHILIPPINE CONGRESS AND SENATE TO PASS A BILL TO THE EFFECT OF MAXIMIZING THE USE OF COCO FUND OUT THE COCO LEVY TO SUBSIDIZE THE PRICE OF COPRA TO BOLSTER AND AUGMENT THE ECONOMIC CONDITION OF THE COCONUT PRODUCERS AND THE COPRA INDUSTRY THE PHILIPPINES;
