RESOLUTION AUTHORIZING HONORABLE CARMELO J. LOCSIN, MAYOR, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT BY AND BETWEEN THE CITY OF ORMOC AND QUEDAN. AND RURAL CREDIT GUARANTEE CORPORATION (QUEDANCOR) TO ALLOW THE LGU-ORMOC TO PARTICIPATE IN THE LOAN PROGRAM OF QUENDANCOR UNDER THE GMA-CARE-IAL.

WHEREAS, this Sanggunian is in receipt of 2nd Indorsement dated 05 March 2002 from the Office of the City Mayor requesting this august Body to pass a resolution authorizing the Honorable City Mayor to enter into and sign a Memorandum of Agreement to allow the LGU-Ormoc to participate in the loan program of QUEDANCOR under the GMA-CARE-IAL together with copies of Memorandum of Agreement for said loan program;
