

RESOLUTION NO. 2002-072

RESOLUTION EARNESTLY REQUESTING ATTY. FIEL I. CENR OFFICER, DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES, CENRO, ALBUERA, LEYTE FOR HIS OPINION ON THE CLOSING OF THE TRADITIONAL ROAD FROM SITIO MANGGA, BRGY. SAN JUAN, UP TO THE SEASHORE WHICH IS CLASSIFIED TIMBERLAND AND NOW FORM PART OF THE FISHPOND OF MR. MANUEL CHUA.

WHEREAS, this august Body is in receipt of an unnumbered resolution series of 2001 from the Brgy. Council of Brgy. San Juan, this city entitled, "A RESOLUTION EARNESTLY REQUESTING THE HONORABLE CITY MAYOR CARMELO J. LOCSIN TO INTERCEDE FOR AND IN BEHALF OF THE RESIDENTS OF THIS BARANGAY AFFECTED BY THE CLOSURE OF THE TRADITIONAL ROAD FROM SITIO MANGGA UP TO THE SEASHORE WHICH NOW FORM PART OF THE FISHPOND LEASE HOLD OF MR. MANUEL CHUA";

WHEREAS, on February 16, 2002, a consultative meeting was held and attended to by representatives of Brgys. Curva, San Juan, Margen and Mabato wherein, it was agreed that said barangays were unanimous in their stand to earnestly request Mr. Chua not to close said traditional road for it is the only road which gives them access to the seashore and for them to earn a living as fishermen;



WHEREAS, at present, said road is closed since it becomes a part of the fishpond of Mr. Chua and being as such, the fishermen from said barangays can no longer fish for a living thereby depriving them of their means of livelihood;

WHEREAS, with this development, it is suggested that DENR should conduct a survey in order to delineate the traditional road thereby giving access to the fishermen concerned;

WHEREAS, it is further suggested that, the DENR should act on the same within fifteen (15) days from receipt of this resolution taking into consideration the plight of the fishermen in the said area;

WHEREFORE, foregoing premises considered, on MASS MOTION of the Body; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution EARNESTLY REQUESTING ATTY. FIEL I. MARMITA, CENR OFFICER, DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES, CENRO, ALBUERA, LEYTE FOR HIS OPINION ON THE CLOSING OF THE TRADITIONAL ROAD FROM SITIO MANGGA, BRGY. SAN JUAN, UP TO THE SEASHORE WHICH IS CLASSIFIED AS TIMBERLAND AND NOW FORM PART OF THE FISHPOND OF MR. MANUEL CHUA;
