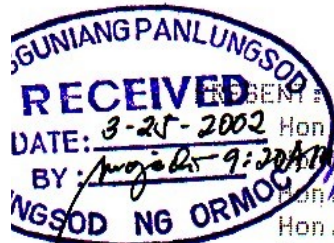

A RESOLUTION EARNESTLY REQUESTING HONORABLE EMILIA BONCODIN, SECRETARY, DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) TO PROPORTIONATELY INCREASE THE AMOUNT OF THE INTERNAL REVENUE ALLOTMENT (IRA) FOR BARANGAY LAO, ORMOC CITY, AS A CONSEQUENCE OF THE MASS RESETTLEMENT OF SOME FIVE HUNDRED HOUSEHOLDS TO THE JICA PROJECT SITE IN BARANGAY LAO, THIS CITY, AS MANIFESTED IN THEIR ATTACHED RESOLUTION NO. 11 SERIES OF 2002.
