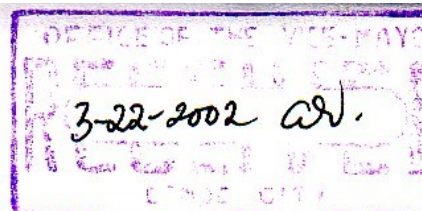
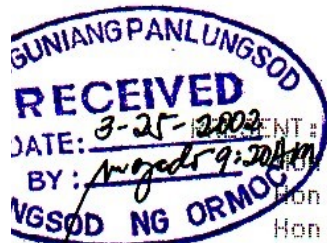

by City Councilor Gregorio A. Yrastorza, Jr.; be it


RESOLVED, to pass a resolution APPROVING THE APPLICATION FOR THE

ADOPTED, March 21, 2002.


RESOLVED, FURTHER, to furnish copies of this resolution each to His
