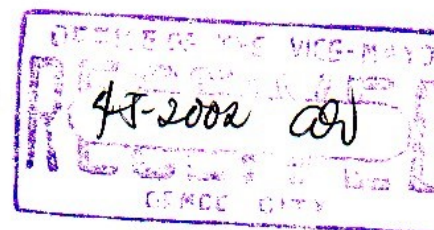

Councilors Chiqui B. Labagala and Fe S. Lladoc; be it


