RESOLUTION NO. 2002-088

A RESOLUTION APPROVING THE RANKING OF FIRMS TO UNDERTAKE THE PROPOSED ORMOC CITY SLAUGHTERHOUSE DEVELOPMENT PROJECT AND TO AUTHORIZE THE HONORABLE CITY MAYOR CARMELO J. LOCSIN TO NEGOTIATE WITH THE THREE (3) RANKED FIRMS PROVIDED THAT WHATEVER AGREEMENT ENTERED INTO BY ANY PARTIES WILL BE SUBJECT FOR APPROVAL BY THE SANGGUNIANG PANLUNGSOD NG ORMOC.

WHEREAS, this august Body is in receipt of 1st Indorsement dated 15 March 2002 from the Acting City Mayor, Atty. Ari G. Larrazabal requesting this sanggunian for an urgent passage of a resolution approving the ranking of firms to undertake the proposed Ormoc City Slaughterhouse Development Project and requesting that the Honorable City Mayor Carmelo J. Locsin be authorized to negotiate with the First - In - Rank firm;

WHEREAS, as stated in PBAC Resolution No. 2002-04, the City of Ormoc recognizes the need to construct a new state-of-the-art slaughterhouse to provide Ormocanons with better quality meat products;

WHEREAS, the same PBAC Resolution has further stated that the committee adopts and endorses the findings of the Technical Committee on the Technical Qualifications of the three (3) firms and recommends to enter into negotiation with the first in Rank Firm for the Proposed Ormoc City Slaughterhouse Development Project with the following ranking of firms:

1. AVM Bernardo Engineering
2. JOC Fabrication and Construction Corporation
3. RZL Builder and Traders

WHEREAS, this august Body has conformed to the findings of the PBAC and believes that said request be given due course of action;

WHEREFORE, foregoing premises considered, on motion of City Councilor Jovencio A. Laurente, Chairman, Committee on Infrastructures, jointly seconded by City Councilors Gregorio A. Yrastorza, Jr., and Eduardo P. Tan; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution APPROVING THE RANKING OF FIRMS TO UNDERTAKE THE PROPOSED ORMOC CITY SLAUGHTERHOUSE DEVELOPMENT PROJECT AND TO AUTHORIZE THE HONORABLE CITY MAYOR CARMELO J. LOCSIN TO NEGOTIATE WITH THE THREE (3) RANKED FIRMS PROVIDED THAT WHATEVER AGREEMENT ENTERED INTO BY ANY PARTIES WILL BE SUBJECT FOR APPROVAL BY THE SANGGUNIAN NG ORMOC;
