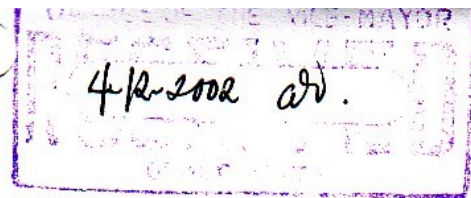

afternoon at the Sangguniang Panlungsod Session Hall;
