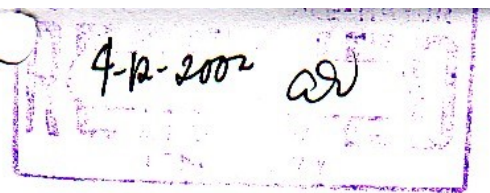
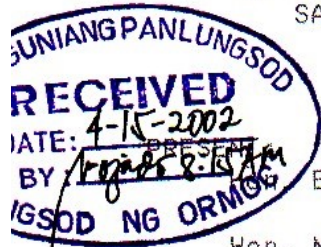

RESOLUTION NO. 2002-091

A RESOLUTION REQUESTING THE PERMITS, LICENSING AND
FRANCHISING DIVISION TO SUBMIT TO THE SANGGUNANG
PANLUNGSOD NG ORMOC THROUGH THE COMMITTEE ON
INDUSTRIAL LABOR FOR SCREENING PURPOSES ALL DOCUMENTS
RELATIVE TO THOSE RECRUITMENT AGENCIES APPLYING FOR
LICENSE/PERMIT WITH THE SAID OFFICE.

WHEREAS, much is heard about illegal recruitment prevailing in the
City of Ormoc practiced by a recruitment agency tasked to hire employees
specially for abroad;

WHEREAS, sad to say those victimized are mostly Ormocanons who have
planned to seek for greener pastures but these plans never materialized
for they fell victims of this so called illegal recruiters;

WHEREAS, in order to stop this practice of economic sabotage, this
August Body through the representation of the Honorable Members
Committee on Industrial Labor decided to screen the documents of those
recruitment agencies applying for licenses/permits with the Permits,
Licensing and Franchising Division of this city so as to avoid future
activities of illegal recruitment and at the same time curb such form of
malfeasance in our society;

WHEREFORE, foregoing premises considered, on motion of City
Councilor Ruviniou E. Mendola, Chairman, Committee on Agricultural and
Industrial Labor, jointly seconded by City Councilors Fe S. Lladoc & Jose
S. Serafica; be it
