WHEREAS, Ordinance No. 089-02 dated February 2002 was enacted by this Sanggunian for purposes of amending Ordinance NO. 34 dated November 24, 1992 and Ordinance No. 58 dated January 16, 1997;

WHEREAS, inspite of its approval, Ordinance No. 089-02 has to have implementing guidelines to guide the operators in the acquisition, sale, transfer and disposition of units and that the same will conform with the standard requirement in the Land Transportation. Office (LTO) for registration of tricycles for hire;

WHEREAS, said implementing guidelines have been thoroughly studied by this august Body and found out that the same is valid and reasonable, hence, be accorded due course of action; (copy hereto attached)

IMPLEMENTING GUIDELINES OF CITY ORDINANCE NO. 34-92 GRANTING FRANCHISE (MTOP) TO MOTORIZED TRICYCLE FOR HIRE (Effective April 1, 2002)

SECTION 1. DEFINITION OF TERMS:

- a)Unit refers a motorcycle unit/tricycle for hire.
- b) Tricycle a motorcycle unit with a side car.
- c) MTOP (Motorized Tricycle Operators Permit) a document granting franchise on license to operate to a person, whether natural or juridical, allowing him to operate a tricycle for hire valid for three (3) years from date of approval and renewable for the same period.
- d) Dropping is a document issued to an operator who cease to operate his unit/tricycle for hire or has sold or dispose his unit.
- e) Increase of unit/tricycle for hire refers to additional unit of an existing holder of MTOP.
- f) Substitution of unit/tricycle for hire refers to change of unit.
- g) Approval of Sale and Transfer refers to a document issued to a new operator who acquired a unit with existing MTOP through sale or transfer.
- h) Confirmation is a document issued to an operator stating that his unit/tricycle for hire has valid and unexpired franchise (MTOP) to operate, for purpose of renewing his LTO registration.

SECTION II. RULES OF ENTRY

- a. All petitions for increase of unit/tricycle for hire, substitution of unit/tricycle for hire, approval of sale and transfer shall be set aside and deleted from the transactions of the Board. Henceforth all petition involving those transactions shall now be treated as PETITION for NEW MTOP.
- b. Transaction with the BOARD shall consist of the following:
 - a. Petition for New MTOP.
 - b. Petition for Renewal of MTOP.
 - c. Petition for Dropping of Unit/Tricycle for hire.
- The City Legal Officer representing as Board Hearing Officer shall also be responsible inthe confirmation of all valid MTOP.
