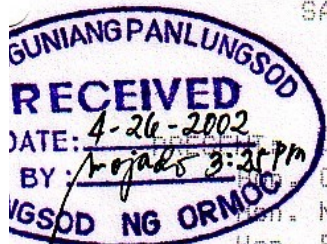

ADOPTED, April 25, 2002.


