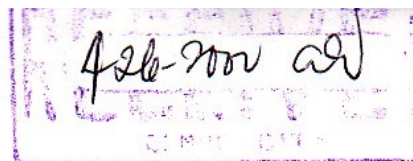



RESOLVED, FINALLY to affix our signatures on this Resolution of Condolence, and be it


