



A RESOLUTION AUTHORIZING THE CITY ACCOUNTANT TO CHARGE  
THE AMOUNT OF NINE HUNDRED SIXTY PESOS AND 96/100  
(₱960.96) AGAINST CURRENT APPROPRIATION FOR SALARIES  
AND WAGES OF PUBLIC AFFAIRS OFFICE FOR THE PAYMENT OF  
SALARY STEP INCREMENT OF MS. LILIAN A. POCSO COVERING  
THE PERIOD FROM OCTOBER 16, 2001 TO DECEMBER 31, 2001.

WHEREAS, this august Body is in receipt of 1st Indorsement dated 17 April 2002 from the Acting Secretary to the Mayor requesting for Supplemental Appropriation in the amount of NINE HUNDRED SIXTY PESOS AND 96/100 (₱960.96) for payment of Salary Step Increment Difference of Ms. Lilian A. Pocsos, Community Affairs Officer II, Public Affairs Office, this city;
