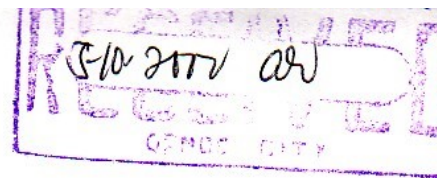
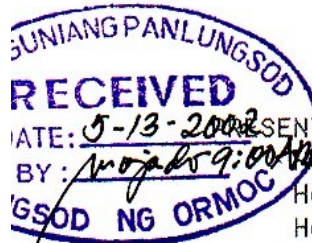

RESOLUTION NO. 2002-111

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR CARMELO J. LOCSIN TO ENTER INTO A CONTRACT, ABSOLUTE OR CONDITIONAL, FOR THE SALE OF LOTS AT BARANGAY SAN ISIDRO, ORMOC CITY, THE SITE OF THE ORMOC CITY GOVERNMENT HOUSING PROGRAM TO QUALIFIED BENEFICIARIES/AWARDEES.

WHEREAS, this august Body is in receipt of 1st Indorsement dated 29 April 2002 re: letter request of the Honorable Carmelo J. Locsin, City Mayor of Ormoc requesting for an authority to enter into a contract, absolute or conditional, for the sale of lots at Barangay San Isidro, this city, of the Ormoc City Government Housing Program to qualified beneficiaries/awardees and further requesting for urgent favorable action on the same;

WHEREAS, it can be recalled that this august Body has approved the implementing rules and regulations of the said housing program for the Ormoc City Government employees through Sangguniang Panlungsod Resolution No. 2001-065 dated 04 October 2001;
